Primary radio operations for the AWRR and A&TC have moved to the Lower Colorado River Authority Trunked Radio System. Dispatching duties are handled by Austin's Capital Metro transit authority, which also uses the LCRA system. The LCRA System is a 900Mhz analog EDACS system, which means that rail operations can be monitored with a trunk-tracking capable scanner. All track warrants are given out on channel 5, the primary operating channel. Switching operations use channels 1 or new unidentified talkgroups CM_R_YRD2 or CM_R_YRD3 so as to not overlap. DMU testing is done on channel 2 after warrants are granted on channel 5. Little if anything is heard on channels 7, 8, or 9 at present.
